Regarding the amendment of Terminal Service Tariff

- Pursuant to Decisions No. 809/QD-BGTVT, 810/QD-BGTVT, and 811/QD-BGTVT issued on 01/7/2024 by the Ministry of Transport on promulgation of charge bracket for use of wharves, docks and mooring buoys, container handling services, and towage services at Vietnamese seaports;
- Based on market conditions;

DECIDES

Article 1: To amend and supplement Domestic Terminal Service Tariff applicable to domestic shipping lines and cargo owners with import, export, transit, and domestic cargo at Haiphong Port TIL International Terminal Co., Ltd issued as per Decision No. 86/QD-HTIT dated 03/4/205 and International Terminal Service Tariff applicable to domestic shipping lines and cargo owners with import, export, transit, and domestic cargo at Haiphong Port TIL

International Terminal Co., Ltd issued as per Decision No. 87/QD-HTIT dated 03/4/2025. Details of amendments and supplements are as per the Revised Terminal Service Tariff (1st Amendment) enclosed to this Decision.

REVISED TERMINAL SERVICE TARIFF (1st AMENDMENT)

(Enclosed to Decision No. 257/QD-HTIT dated 21/08/2025)

I. SCOPE OF AMENDMENT:

- This Tariff amends and supplements the contents of the Domestic Terminal Service Tariff applicable to domestic shipping lines and cargo owners with import, export, transit, and domestic cargo at Haiphong Port TIL International Terminal Co., Ltd issued as per Decision No. 86/QD-HTIT dated 03/4/205 (hereinafter referred to as the "Original Domestic Tariff").
- This Tariff amends and supplements the contents of the International Terminal Service Tariff applicable to international vessel owners/shipping agents at Haiphong Port TIL International Terminal Co., Ltd issued as per Decision No. 87/QD-HTIT dated 03/4/2025 (hereinafter referred to as the "Original International Tariff").
- Any contents of the Original Domestic Tariff and Original International Tariff not amended or supplemented herein shall remain unchanged.

II. AMENDMENTS TO THE ORIGINAL DOMESTIC TARIFF:

1. Definition

- To amend and supplement Article III Chapter I of the Original Domestic Tariff regarding the Definition as follows:
- 8. Hazardous, Dangerous Container (DG): A container that has hazardous elements, including but not limited to: containers (laden or empty) that contain goods, residues/remnants, or equipment with toxic and dangerous properties that pose risks to humans, vessels, and the environment, in accordance with Vietnamese law and relevant international treaties to which Vietnam is a signatory or has participated.
- 13. Normal Container: A container that does not have hazardous, dangerous, oversized, or overweight elements and/or does not require special handling operations.

2. Berthing service

- To supplement the following content to Schedule 3 – Chapter II – of the Original Domestic Tariff: "Schedule 3 applies to vessels berthed for cargo handling purpose"

3. Container loading/discharging service from Yard to Truck or from Truck to Yard (Container lift-on/Lift-off)

- To amend the unit prices in Schedule 4.2 – Chapter II of the Original Domestic Tariff as follows:

3. Container loading/discharging service

- For DG or OOG containers (that the Terminal's existing equipment can handle): supplement "Increase by 50% the unit price as specified in Schedule-4.4 of the respective container type and activity"
- For DG and OOG containers (that the Terminal's existing equipment can handle): supplement "Increase by 50% the unit price as specified in Schedule-4.4 of the respective container type and activity"
- Handling charge for bundle of flatrack containers (maximum of 4 containers per bundle): supplement "Each bundle is subject to 100% of the unit price under Schedule-4.4 of the respective **laden** container type and activity"

* DG Container shall be interpreted in accordance with the definition of DG container as amended, supplemented in this Revised Terminal Service Tariff.

5. Container storage at yard

- To remove "For export containers, storage time is calculated from the date the container is dropped off at the yard until the vessel's estimated departure date as registered by the shipping line" from Schedule 6 Chapter II of the Original International Tariff.
- To amend and supplement the following content to Item 6.1 Schedule 6 Chapter II of the Original International Tariff:

From 01/9/2025 onwards:

+ Normal laden container:

the first 03 days of storage at yard (including Sundays and public holidays)

+ Other container types:

no free storage time is applied

- To amend the following contents to Schedule 6.2 - Chapter II of the Original International Tariff:

For DG/OOG container: Increase by 50% the unit price as specified in Schedule 6.2 of the respective container type.
